Program Information

Public Health connects populations from an integrated approach including identifying and impacting change in behaviors that affect health; education on the science of primary prevention of disease; promoting healthcare equity, quality and accessibility; and advocating for improved healthcare systems.

Completion of a Bachelor of Public Health (BPH) degree prepares students for the public health workforce and equips them to find effective and meaningful solutions for real-world health problems. The College has strong ties to the public health practice community, both regionally and nationally, and provides students with opportunities to engage with professionals across the country. BPH graduates are well-positioned to pursue entry-level positions in community and public health and healthcare, as well as for graduate study in public health and a variety of other health professions.

Students enrolled in the BPH should have both a belief in making positive changes and a devotion to making a difference in the health status of communities.

Program Outcomes

Students in the Bachelor of Public Health degree program will be able to complete the following learning outcomes upon completion of the curriculum:

1. Demonstrate knowledge of public health from an interdisciplinary perspective.
2. Show competency in ethical issues, social responsibility, and problem solving using evidence-based concepts in core public health areas.
3. Show competency in relationship-building and team dynamics to plan and promote public health and reduce health disparities.
4. Apply theories and concepts to communicate the interconnectedness among the physical, social, and environmental aspects of population health.

Program Requirements

The College of Public Health requires students to earn a minimum of 120 hours for the Bachelor of Public Health with a minimum cumulative grade-point average of 2.5. In addition, students must earn a grade of C or better in all major requirement courses. Students may take additional hours in accordance with stated University policy.

Academic & University Policies

Admission Policy

Admission to the University as an incoming freshman is sufficient for admission to the Pre-Bachelor of Public Health (pre-BPH) program. Students participating in the Academic Preparation Program are not eligible for admission. Current University students and transfer students must meet the BPH grade-point average (GPA) admission criteria to be admitted as a pre-BPH student. Admission to the pre-BPH program does not guarantee admission to the Bachelor of Public Health (BPH) program. Students may apply to the pre-BPH program during the university approved window to declare a major. Admission to the Bachelor of Public Health Program happens in two stages, pre-major status and BPH status. Pre-major students are students who are working on entry level requirements. Once these students meet the criteria described below, they may apply for BPH status.

1. Enrollment in the University of Kentucky
2. Completion of CPH 201 with a letter grade of B or higher
3. Completion of all additional pre-major required courses with a letter grade of C or higher and combined 3.0 GPA
4. Cumulative GPA of 2.75 or higher
5. Submission of an application form to the College of Public Health prior to the annual application deadline of June 1st. The application is available at: <http://cph.uky.edu/admissions/bachelor-public-health-admissions/bachelor-public-health-applications>

Applications to the BPH program are only accepted from February 1st - June 1st each year. All pre-major requirements must be complete prior to the start of the following fall semester to be eligible for admission. All applications will be processed after June 1st, and admissions status will be released to students no later than July 15th of the current academic year.

Appeals Process

Students who do not meet the GPA criteria for admission to the Bachelor of Public Health program, but have extenuating

circumstances that prevented them from reaching their academic potential may submit an appeal at the time their application is submitted.

Accelerated BPH/MPH Degree Program

The College of Public Health offers an Accelerated Bachelor of Public Health (BPH)/ Master of Public Health (MPH) Degree Program, which provides high achieving students an opportunity to complete both the BPH and MPH degrees in five, rather than six, years. This program aligns with the University of Kentucky's guidelines for a University Scholars Program. Students admitted to the Accelerated BPH/MPH Degree Program will have the opportunity to complete twelve hours of their MPH required coursework during their final year of undergraduate study. The tuition cost for these hours will be set at the student's current undergraduate tuition rate. Tuition during the final year of study will be based on the University of Kentucky's graduate tuition rate.

Completion of this program will prepare students for careers in government public health, non-profit organizations, environmental or emergency preparedness organizations, or many other public health related fields. Graduates will also be well positioned for admission into professional programs such as medicine, pharmacy, physician assistant, physical therapy, and law.

Students will apply to the Accelerated BPH/MPH Degree Program during the open registration window for the UK MPH program during their junior year. This window typically opens in mid-August and is available until March 15 for international students and April 1 for domestic students. Students wishing to

apply for the program must fulfill the following requirements:

1. Admission to BPH program
2. Cumulative GPA of 3.2 or higher
3. Major GPA of 3.5 or higher
4. Completion of the GRE with competitive scores

Students meeting the above criteria are eligible to apply for the Accelerated BPH/MPH Degree Program. Follow these steps to complete your application:

Step 1: Apply to SOPHAS

The UK Master of Public Health program offers five concentrations including Biostatistics, Epidemiology, Health Behavior, Environmental Health, and Population Health Policy and Management. Applications must be submitted to the Accelerated BPH/MPH Degree Program with a concentration in one of these fields.

Note: Applications submitted to the UK MPH program rather than the Accelerated BPH/MPH Degree program will not be reviewed.

You will need the following to complete your application:

1. CV or resume
2. Statement of purpose and objectives
3. Transcripts for ALL higher education institutions attended
4. International transcripts should be evaluated by WES

Students should ensure that following are sent directly to SOPHAS:

1. GRE scores
2. For international students, official TOEFL or IELTS scores
3. Letters of recommendation

To be eligible for any opportunities offered by the College please answer “yes” as indicated on the financial assistance portion of your SOPHAS application. There may also be separate announcements via email.

Step 2: Apply to the UK Graduate School (supplemental application)

Your Graduate School application is for admission to the University of Kentucky

- All graduate students, included Accelerated Degree students, must submit an application to the graduate school
- All information received from your SOPHAS application is sent to the Graduate School from the College of Public Health.
- When completing your application for the Graduate School, you can either upload the documents that you used for your SOPHAS application, or you can submit blank documents as place holders.
- The application fee is \$65 for domestic applicants and \$75 for international applicants and is non-refundable.

You will not need to complete the Assistantship Application as part of the Graduate School Supplemental Application. That is an optional section that some other programs use; the College of Public Health does not use that application. You can upload a blank document for this section. Information about assistantship opportunities within the College will be shared with students as they become available.

Applications to the Accelerated BPH/MPH Degree Program will be reviewed following the completion of the spring term. Students will be notified of their admission status no later than July 1. The Admissions Committee take into account many factors for admissions decisions. The Committee requires a minimum undergraduate GPA of 3.2 and a major GPA of 3.5 for applicants to the Accelerated Degree program. Official GRE scores are preferred at 50th percentile or better. Students meeting the minimum criteria for application are not guaranteed a placement in the program, as spots are limited.

Academic Policies

core courses in order to complete the major requirements and advance through sequential public health courses. A grade lower than a C will require the student to repeat that course and obtain a C or better to meet major requirements.

- A student has the option to repeat once as many as three different courses in which he/she received a grade of B, C, D, or E. This is called a Repeat Option. Only the grade, credit hours, and quality points of the second completion will be used in calculating the GPA, provided the student has made a specific request through a Repeat Option form (available from your advisor). A limit of three repeat options may be filed during your entire undergraduate career. The student must be enrolled at the time the repeat option form is filed.
- Students who have a term grade point average of 3.5 or greater will appear on the Dean's List.

Probation and Suspension Policies

University of Kentucky probation and suspension rules apply for all university undergraduate students. These rules may be reviewed in the Academic Requirements bulletin found here:

The following additional rules apply to students in CPH:

- Any student who fails to maintain a cumulative UK GPA of 2.5 shall be placed on academic probation within the College of Public Health.
- A student will be removed from academic probation when a cumulative GPA of 2.5 or higher is obtained.
- A student shall be dismissed from the College if he/she fails to achieve a cumulative GPA of 2.5 or higher within two consecutive semesters of being placed on probation or fails to earn a term GPA of 2.5 or higher for any two consecutive semesters following his/her placement on academic probation.
- A student who earns a term GPA of 2.5 or higher for each semester following placement on probation will continue in probationary status until a cumulative GPA of 2.5 or higher is obtained.
- Students who are on academic probation within the College of Public Health may transfer to other colleges or departments during any major change window provided the students meet eligibility criteria.
- A student who has been dismissed from the College for

academic reasons and has remained outside the program for at least a semester and a summer session, may petition for reinstatement. Petition for reinstatement is to be made in writing to the Dean or Associate Dean of Academic and Student Affairs in the College of Public Health and shall include a written statement by the student specifying why he/she should be considered for reinstatement. After consultation with the Director of Undergraduate Studies and other faculty as appropriate, the Dean may choose to accept or deny the petition. The Dean may require that the student agree to certain conditions in order to be reinstated (i.e. take additional course work, complete a writing class, obtain tutoring). The Dean shall inform the student in writing that he/she has been reinstated or reasons for denial of the petition for reinstatement. No student will be readmitted to the College via reinstatement request more than twice.

- A student who has been dismissed for academic reasons and reinstated shall, upon reinstatement, be placed on academic probation and be subject to the academic performance expectations outlined in this policy.

Academic Integrity, Cheating, and Plagiarism

Students are expected to adhere to the highest standards of academic honesty. Cheating, plagiarism, and destruction of course materials violate the rules of the University. Violations of the university's rules regarding academic honesty can lead to a failing grade in the course and suspension, dismissal, or expulsion from the University. Instances of academic dishonesty will be reported to appropriate University officials as required by University rules and procedures. **It is the student's responsibility to read and understand university policies on academic dishonesty. Lack of familiarity with the policy will not be taken into consideration when determining punishment.**

Class Attendance

Every student is expected to attend all class sessions, including laboratories, other outside-the-classroom activities as deemed necessary by the course instructor, and to complete all examinations. Each instructor determines his/her individual policy for class attendance, completion of assigned work, absences at announced and unannounced examinations and excused absences. A student has the right to expect this policy to be in writing and given to him or her by the first or second meeting of the class. Failure to comply with these rules may result in lowered grades.

In all cases, the student bears the responsibility for notifying the instructor of any missed work and for making up any missed work. If feasible, the instructor may give the student an opportunity to make up the missed work or examination missed due to an absence during the semester in which the absence occurred.

Class Cancellations

The University never entirely closes, but there may be a rare cancellation of classes due to inclement weather. Announcements of cancellation or delay of classes normally will be made by 6 a.m. through the local media. The latest information will be on the UK Infoline at (859) 257-5684, UK Cable Channel 16, or UK website, <http://www.uky.edu>. Those students who are participating in an off-site experience will be expected to follow the cancellation/closing policies of the agency/clinic/company where they are assigned.

Confidentiality and Disclosure

The Family Education Rights and Privacy Act of 1974 (FERPA, also known as the Buckley Amendment) provides basic privacy rights to students in regard to their academic transcripts. Under FERPA provisions, students have the right to have their academic record kept separate and confidential unless they consent in writing to have it released. However, FERPA also provides that the College of Public Health may disclose (to University personnel) the student's academic record without the student's consent when the person requesting the information has a legitimate educational interest and the information is used under the following disclosure guidelines and for the purpose of:

1. academic advising

2. writing a letter of recommendation requested by the student. (If the student is requesting a letter be sent to someone outside the University of Kentucky, the Release of Information Consent Form must be completed: <http://cph.uky.edu/resources/student-resources/release-information-consent-form-academicprofessional-reference>)
3. selecting students for honorary organizations
4. informing community-based faculty members serving as preceptors
5. responding to a directive pursuant to law or court order

Confidentiality of Student Records, Address Information, and Student Rosters

Transcripts and grade information will be released only upon written authorization from the student. Directory information (name, address, telephone listing, date and place of birth, major, dates of attendance, degrees, and most recent educational institution attended) will be released without authorization unless the student notifies the Registrar in writing to the contrary. Official University of Kentucky College of Public Health student records are kept by the Office of Student Engagement, Advising and Success in a locked cabinet, with access restricted to authorized personnel.

The College of Public Health does NOT make lists of students, addresses, phone numbers, e-mail addresses, etc. available to anyone other than students, faculty and staff of the school. Students are instructed NOT to distribute the lists of their classmates to individuals outside the College.

At UK, students can use the UK website to access important information, including grades, student schedules and registration information. Students also can update their addresses and other information, <https://myuk.uky.edu/irj/portal>.

Dress Code

All students should maintain a clean, neat appearance at all times, and students' attire should be commensurate with the activities in which the student will participate during that day. A professor may set forth additional standards of attire in his or her syllabus. This policy is designed to provide a reasonable standard of dress and appearance for public health students. If a faculty member deems a particular student's attire to be inappropriate, according

to program guidelines or according to the class syllabus, he or she may notify the student privately at any time before, after, or outside of class and ask the student to correct the problem.

Diversity, Equal Educational and Employment Opportunities

The College of Public Health and University of Kentucky strive to develop an environment where the value of diversity among students, faculty and staff is accepted, encouraged and embraced. Diversity encompasses differences in age, ethnicity, gender, national origin, race, religion, sexual orientation, socioeconomic background and unique individual style. The individual characteristics, talents and contributions of all people are valued and recognized for the unique contribution they make to our College. The following statement, required on all official UK documents, guides all admissions and employment practices, and represents the best expression of the CPH commitment to diversity.

The University of Kentucky is committed to a policy of providing educational opportunities to all qualified students regardless of economic or social status, and will not discriminate on the basis of race, color, religion, sex, marital status, beliefs, age, national origin, sexual orientation, or physical or mental disability.

Drug Free Institution

The Drug-Free Workplace Act of 1988 and the Drug-Free Schools and Communities Act Amendment of 1989 set a standard of behavior, which affects students who are on University of Kentucky property, on University business, or at University-sponsored events. The University policy, as well as the laws from which the policy is derived, define conduct related to the unlawful possession, use, dispensation, distribution or manufacture of alcohol or illicit drugs. Electronic Devices

Out of respect for classmates and faculty, all students are asked to function in a professional manner as it relates to the use of electronic devices during class sessions. Cell phones, pagers, etc. are disruptive to classroom activities and may be requested to be deactivated upon entering the classroom. Instructors may ask that laptops be closed during lectures.

Health Care Colleges Code of Professional Student Conduct (HCC Code)

The Health Care Colleges Code of Student Professional Conduct (HCC Code) provides the standards of professional conduct and procedures to be followed when questions arise about the professional, moral or ethical character of a student enrolled in courses or programs, including clinical programs, in the health care colleges, <http://www.uky.edu/regs/files/HCCcode.pdf>.

Procedure for Redress of Grievances

Individual students having a grievance about any aspect of the Program should first take her/his grievance to the Director of Undergraduate Studies. If the Director cannot resolve the issue, the grievance should then be taken to the Associate Dean for Academic Affairs in the College of Public Health. The Dean of the College of Public Health is the next administrative level for student grievances. Following initial review, a student may choose to approach the Graduate School (for graduate programs) and/or the University Ombud for undergraduate and professional programs.

Social Media Guidelines

UK HealthCare recognizes the impact of social media (Facebook, Twitter, Instagram etc.) on our workforce. Our expectation is that faculty, trainees, students and employees know what is expected in health care and observe policies on behavioral standards, patient privacy, use of personal electronic devices and hospital resources. Patient privacy is vitally important and we train regularly on obligations related to privacy and security matters (HIPAA). Recent changes to HIPAA rules require that the federal government is notified when patient privacy has been violated.

Below are some expectations when using social media sites.

- Do not “friend” patients/clients
- Do not accept “friend requests” from patients/clients or their family members
- Never share any patient information via Facebook or other social media
- Never post pictures of patients or pose with patients/clients for pictures
- Never give medical advice via social media

Smoke-Free Environment

On April 22, 2008, the UK Board of Trustees gave final approval to the revised version of the university policy that outlines the university's smoke-free policy. Tobacco use is not allowed on University property.
